Terms & Conditions

Tour Price: Tour Price is based upon the elements of the tour and a minimum number of travelers. Any changes to the tour elements, change in the number of travelers and/or Tour Participants or an increase in supplier costs (i.e. fuel surcharges or tax increases) may cause the Tour Price, and therefore the payment schedule to change.

Deposits and Payments: A completed Registration Form, non-refundable booking deposit and payments are due to First Ladies by the date indicated on the Registration Form. Make all payments payable to First Ladies. Checks, cash, money orders or credit card payments are accepted. A (convenience) charge for all credit card payments and a \$30 returned check charge on all checks returned for insufficient funds will be incurred. Total Tour Cost is due by June 1, 2018. Please see your First Ladies Representative for details.

Cancellations and Refunds: The deposit and payments as communicated by First Ladies is non-refundable. The deposit reserves a seat and a \$0 balance guarantees the said seat. Payments are not transferrable and cannot be transferred to a student's school, school fees, tuition or after-school program.

Health Proxy Forms and Medical Matters: A complete and accurate Health History and Medical proxy prior can be requested and/or required prior to departure – dependent upon the nature of the activities associated with the Tour. Any medical or physical condition that chaperones should know of or may interfere with your participation on the Tour or with others on the tour must be stated in writing prior to departure. I, the signee authorize the adults on this tour to obtain emergency treatment as deemed necessary by medical professionals for my child and/or I.

Insurance: A copy of your primary medical insurance card and dental insurance card is required before departure.

Behavior: Travelers are responsible for exercising sound judgment, caution and respect for all people, places and things while on tour and are expected to adhere to all rules and regulations set forth by the Trip and chaperones. Failure to do so may result in the traveler being sent home at own expense with no refund.

Transportation: Modern motor coach transportation will be provided for all tours conducted by First Ladies. An experienced driver will operate the motor coach. The motor coach will have all required insurances according to the state of Georgia guidelines. Not included are gratuities for the driver. We recommend \$1 per person to be paid at the end of the trip if excellent service has been rendered.

Alcohol/Drug Policy: First Ladies Youth Leadership has a zero tolerance rule for possession or drinking of alcohol for all of its travelers and possession or use of any illegal drug or drug paraphernalia by all travelers. Any traveler violating this rule is subject to immediate expulsion from the Trip. In any such case, the travelers parent/guardian is responsible for transporting the traveler home, and waives any claim for any refund of any portion of the Trip cost.

Responsibility and Compulsory Arbitration:

This form is important. It includes Terms & Conditions and releases First Ladies International, LLC and First Ladies Youth Leadership, Incorporated and its representatives which for this contract include its officers, directors, shareholders, subsidiaries, affiliates, successors, partners, agents, volunteers, assigns, interns and employees (collectively "First Ladies"), your school or other sponsor, city or town, Board of Education, chaperones, if applicable, and its and their employees, (collectively, "Sponsor") from liability. All participants and parents or guardians of participants under age 18 must sign the said Registration forms. I understand and agree that this Agreement shall constitute a binding contract between the undersigned and First Ladies International, LLC and First Ladies Youth Leadership, Incorporated. First Ladies does not own or operate or control any person or entity which is to or does provide goods or services for your trip, including, for example, lodging facilities, airline, vessel, bus or other transportation companies, guides or guide services, local ground operators, sightseeing operators, visa processing services, providers or organizers of optional excursions, food service of any kind or entertainment providers, etc. All such persons and entities are independent contractors. As a result neither First Ladies nor your Sponsor is liable for any negligent or willful act or failure to act or of any such person or entity or of any third party. Without limitation, neither First Ladies nor your Sponsor is responsible for any injury, loss or damage to person or property, death, delay or inconvenience in connection with the provision of any goods or services whether occasioned by or resulting from, but not limited to, acts of God, force majeure, war or civil unrest, insurrection or revolt, strikes or other labor activities, criminal, terrorist or threatened terrorist activities of any kind, lost or stolen belongings, overbooking or downgrading of accommodations, structural or other defective conditions in lodging facilities (or in any heating, plumbing, electrical or structural problem therein,) mechanical or other failure of airplanes or other means of transportation or for any failure of any transportation mechanism to arrive or depart timely, dangers associated with animals, sanitation problems, food poisoning, epidemics or the threat thereof, illness, disease, lack of access to or quality of medical care, difficulty in evacuation in case of a medical or other emergency, or for any other cause beyond the direct control of First Ladies International, LLC and First Ladies Youth Leadership, Incorporated. Changes in hotels or itinerary may be made at the discretion of First Ladies or your local ground operator as it or they deem necessary or desirable. Upon making payment for this trip, any controversy or claim arising out of or relating in any way to these Terms & Conditions or any other information relating in any way to the trip, or to the trip itself, shall be settled solely and exclusively by binding arbitration in the state of Georgia in accordance with the commercial rules of the American Arbitration Association that is in existence at that given time. In any such arbitration the substantive law of Georgia will apply. The arbitrator and not any federal, state or local court or agency shall have exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, conscionability, or formation of this contract, including but not limited to any claim that all or any part of this contract is void or voidable. First Ladies reserves the right to take photos, film and/or record any portion of its trips. All guardians and/or persons traveling agree that First Ladies may use any such photos or film records for promotional and/or commercial purposes, as well as approve of such use by third parties with whom First Ladies may engage or partner with without any remuneration to the guardian and/or traveler. The guardian and/or traveler assigns to First Ladies all right, title and interest in or to any and all media in which his or her name or likeness might be used. First Ladies reserves the right to decline to accept or retain any person as a member of any trip. In the event a member is expelled from a trip, no refund of any kind will be made. First Ladies reserves the right to cancel any trip due to unforeseen circumstances.
